A charge of 1 1/2% per month (18% annum) will be added to all past due accounts. If the vehicle is not picked up within 3 days of job completion, storage charges of \$50 per day will be added to the amount due. Purchaser must personally guarantee full payment of this transaction in credit card or cashier check in case of dispute or stop payment. In the event of default of payment of purchaser's account with Giant Motors, purchaser hereby agrees to pay all collection costs, attorney's fees and court costs extended by Giant Motors.
